Spotlight on: Coon Rapids



Coon Rapids Steps Up Sustainability, Fresh Retail and Community Outreach

Coon Rapids Earns SolSmart Silver and GreenStep 3 Designations

Did you know nearly 50 property owners in Coon Rapids currently have solar energy installations? The City of Coon Rapids is committed to solar as an energy option and it is easier than ever for residents and businesses to install solar energy systems. A new streamlined permit process and updated City ordinance reduce the time and money it takes to go solar. The improvements earned Coon Rapids a "Silver" designation from SolSmart, a national program that recognizes communities for removing obstacles to solar. Coon Rapids is proud to be the first SolSmart city in Anoka County.



Solar isn't the only sustainable practice the City has embraced. Coon Rapids also earned a "Step 3" designation as part of the Minnesota GreenStep Cities program. This voluntary program helps cities quantify and achieve sustainability goals that improve quality of life. Coon Rapids implemented several sustainability-related improvements such as LED street lights and traffic signals, two electric vehicle charging stations at City Hall and at the Coon Rapids Ice Center, improved walking and biking trails, and expanded recycling services. In all, Coon Rapids completed over 95 sustainable actions to earn the Step 3 designation.

Ready to Shop? Riverdale Refresh Underway





It's a question we receive a lot at the City... what is being built on that corner? New businesses and renovations are underway in the Riverdale area. The former Sears space in Riverdale Village Shopping Center is under construction to make way for Schneiderman's Furniture (pictured upper left). Work also continues on the reconfiguration of the former JC Penney space in Riverdale Village (pictured upper right), which will become multiple tenant spaces. Meanwhile, Total Wine and More is moving into the former OfficeMax location near Target in Riverdale Commons. And just down the block, housing at Riverdale Station continues to grow with two more apartment buildings planned in 2022. A senior housing complex and a market-rate apartment building will be built next to existing mixed-income and luxury apartment buildings.

Culture and Community: Police Launch Multicultural Advisory Committee

In an effort to strengthen community relations between the police and the public, the Coon Rapids Police Department launched the City's first Multicultural Advisory Committee (MAC) in 2021. The group includes police officers, residents and community leaders from culturally diverse backgrounds. The goal is to build relationships, improve understanding of cultural differences and encourage great discussions.

MAC currently has 16 community members and 6 representatives from the police department. The group gathers monthly to discuss public safety and cultural awareness. At every meeting, a MAC member gives a spotlight presentation sharing their personal story. The presentations are recorded and viewed by all patrol officers in the department to promote a broadened cultural awareness.

Kashkari will address the economy on a national scale and touch on the impact of COVID-19, federal recovery dollars, housing and workforce challenges, and more. Dr. Beaulier has spent his career actively engaged in understanding and advocating for policies that foster dynamic, vibrant economies that best allow businesses and entrepreneurs to thrive. He will discuss how policies are integral to our economic success, and how people - innovative, creative and dedicated business leaders - are the lifeblood of any economy. Commissioner Grove is focused on empowering the growth of the Minnesota economy, and under his leadership, the department works on growing the state's workforce, closing the opportunity gap, and providing businesses and startups the support they need to grow and thrive in Minnesota's economy. Commissioner Grove was previously an executive at Google for 12 years. In addition to these three keynote speakers, there will be panel discussions featuring leaders in agriculture, energy, healthcare, hospitality, manufacturing, and technology.

Our nation recently faced a global recession, record U.S. unemployment and extreme economic uncertainty. This is an opportunity to learn about regional and national trends, understand our biggest threats, examine factors that keep our area competitive, and hear from leaders across various sectors that are the backbone of our economy.

Anoka Area Chamber Manufacturing CoHort Ready for 2022!



The Anoka Area Chamber of Commerce Manufacture CoHort met for working lunch on Tuesday December 28, 2021.

This meeting had a full house and included representatives from manufacturing as well as City of Ramsey, Anoka County and Anoka Technical College.

Agenda centered around the workforce training effort and the application of the \$120,000 MN Dual-Training Pipeline grant that our Chamber was awarded earlier this year.

Beyond the aspect of how fortunate these manufacturers reported they were as a participant in the training that the grant offered to their teams, they are also aware of multiple extended benefits.

These benefits include but are not limited to how the grant and training has open pathways to advanced manufacturing training and individual growth. Additionally, the training has deepened the learning of new job-related skills, and the individuals report being connected to a broader sense of purpose and attachment to their jobs. The employers relate that they believe this training and the program allows participating employees to experience the added value that training brings to their jobs and increases the retention of the employee. Also, this has acted to stabilize the workforce, while deepening a sense of engagement in the organization.

Overall, the CoHort has been given direction to continue to use the MN Dual-Training Pipeline grant as way to support the needs of the industry.

Department of Employment and Economic Development Awards 5 Transportation Economic Development Infrastructure Programs Across Minnesota

Projects will retain or create more than 3,000 jobs

ST. PAUL, Minn. – Today, the Department of Employment and Economic Development announced 5 Transportation and Economic Development Infrastructure (TEDI) projects across Minnesota. The program targets transportation infrastructure projects that create economic development opportunities and jobs, through a collaboration between MnDOT, DEED, and local government and private sector partners.

"This investment in transportation projects will broaden economic development possibilities," said **DEED Commissioner Steve Grove.** "These projects will retain or create more than 3,000 jobs while improving critical pathways to businesses and opportunities in communities across Minnesota."

2021 TEDI Awards


- City of Dayton (\$1,000,000) Assist with construction of a four-lane divided highway linking the new interchange on Interstate 94 to the central part of Dayton. I-94 in this part of the state is one of the busiest freeways in the state (95,000 vehicles per day). The new interchange will provide a new option for traffic that currently goes through the very busy Highway 101 interchange. The project will assist in creating and retaining 1,455 jobs in the area at businesses like Graco, Inc., CRG, Zeigler CAT, ICA Corporation, King Solutions, and others. Tax base increase is estimated at \$134 million in five years. Total cost of the public infrastructure project is estimated to be \$4.57 million.
- City of Chaska (\$487,600) Construction of roadway and sewer along Creek Road to allow full buildout of the 360 acre Southwest Chaska Business Park. The project estimates 5,906 new jobs and a tax base increase of \$46 million in the next 5 years. Oppidan, a developer, has committed to the first development of a \$10.5 million building that will create 301 jobs. The total cost of the infrastructure project is \$14.2 million.
- Renville County (\$200,000) Reconstruct 3 miles of roadway that will primarily serve the Southern Minnesota Beet Sugar Cooperative, Renville County's largest employer. The project will create a wider concrete roadway that will increase safety for the roadway that has high truck traffic. The cooperative is planning a \$175 million expansion. Businesses along the reconstructed road will create or retain 642 jobs and estimate a tax base increase of \$40 million in five years. Total cost of the public infrastructure project is \$2,840,900.
- McLeod County (\$750,000) Extend County Road 5 through a business park in Winsted. The project will expand and provide better access to the existing business park. The expansion will provide 120 additional acres in the park and provide better access to existing businesses such as Millerbernd Manufacturing and RAM. Those two businesses will retain and create 625 jobs and increase tax base by \$28 million in 5 years.
- **Big Stone County** (\$462,400) Construct a roadway that will allow trucks direct access to Highway 75 and bypass residential streets in Clinton. The project will primarily serve CHS, Big Stone Lumberyard, and the Wheaton Dumont Co-op Elevator. The Elevator was destroyed by a fire in 2021. The businesses will create or retain 35 jobs and increase tax base by \$1.5 million in 5 years.

The TEDI Program is a collaborative effort between the Minnesota Department of Transportation. TEDI funds may be used for projects outside of MnDOT rights of way, that will create and retain jobs and increase economic opportunities.


