Oh to be young again with a new season in front of us, or to be graduating and embracing the changes that come with increased opportunities, responsibilities and freedoms!

Speaking of youth and opportunities I had the opportunity to meet with a group of seniors and their teacher, Doug Orr, from the DECA program at Anoka Senior High School. Spotlight on Dayton

The City of Dayton is located in the northwest corner of Hennepin County, with a small portion of the City positioned on the eastern side of Wright County.

Dayton is a growing community with a population of approximately 7,262. Dayton's northern boundary is the Mississippi River, and the Crow River is on the western edge of the City.

The City of Dayton has a range of community resources and facilities to serve the public. City Hall is located at 12260 South Diamond Lake Road, providing offices for Administration and meeting space for the City Council and Commissions. The Police and Public Works Departments are both located at 13700 Zanzibar Lane North. The Public Works Department is responsible for snow removal, street repair, parks and building maintenance, as well as water and sewer services.

The Dayton Police Department is a full-service department, which includes a Chief, a Sergeant, six full-time Officers, a CSO, and two full-time Administrative Assistants. The Department also has a Police Reserve program with volunteer members. The Department provides a number of community services such as Neighborhood Watch, National Night Out, and Operation Identification.

Dayton has a volunteer Fire Department with two stations, an Interim Fire Chief/Assistant Fire Chief and 24 volunteer Firefighters. Fire Station 1 is located in the Historic Village at 18461 Dayton Street (connected to the Activity Center), and Fire Station 2 is located at 12260 South Diamond Lake Road (connected to City Hall).

The Dayton Activity Center is staffed with one full-time Activity Center Coordinator and hosts a variety of events and recreational programming for people of all ages. Fitness classes, holiday events, and the Friday Film Series are a few of the activities currently offered.

Dayton is included within three school districts; Anoka-Hennepin District 11, Elk River School District 728 and Osseo School District 279. Currently, Dayton Elementary School is the only public school located in the City, and is part of Anoka-Hennepin District 11; educating students from Kindergarten through 5th grade.

Dayton is proud of its many commercial and industrial businesses, many of which are located along the junction of Hennepin County highways 81 and 101. The City is committed to continuing to attract economically and environmentally sound commercial development.

Over 4,000 acres of Elm Creek Regional Park are located in Dayton. Elm Creek Park provides hiking, horseback riding, cross country skiing, biking, snowmobile trails, a nature center, playground and picnic area, and a swimming pond. The City also owns and maintains a number of municipal parks.

The Elsie Stephens Farm property (located along County Road 12/Dayton River Road) has been significantly converted to a City park and public gathering place. The property consists of 21 acres adjacent to the Mississippi River, and connects to Dayton's Cloquet Overlook Park, which overlooks Cloquet Island on the Mississippi. An underpass connecting the River Hills neighborhood with Elsie Stephens Park was completed in 2020, allowing safe and convenient pedestrian and bike access to this scenic location.

The City of Dayton has completed and submitted its 2040 Comprehensive Plan, which provides a foundation for development (and redevelopment) of the City in the next 20+ years. Dayton has planned for a community/region-wide transportation system and has identified connections between transportation, transit, pedestrian/bicycle facilities, and land uses.

In November 2021, the City of Dayton (along with several partners) celebrated the opening of the Dayton Parkway Interchange at Interstate 94 near Holly Lane. The location of the Interchange is surrounded by some of the fastest growing communities in Minnesota, along the fastest growing corridor in the state, and on one of the busiest freeways. The opening of the Interchange has improved access to I-94 for emergency vehicles, and has created temporary construction jobs and the potential for hundreds of permanent jobs in the area. The addition of the Dayton Parkway Interchange is expected to generate millions of dollars in new sales, property and income tax revenue.

Dayton is governed by its City Council, consisting of a Mayor and four Council Members. The City Council meets at City Hall on the second and fourth Tuesday each month at 6:30 p.m. for the regular Council meeting. City has three advisory commissions to assist Council in the decision-making process. The Parks Commission, Planning Commission and EDA each meet once per month.

The "Dayton Communicator" is the City's official newsletter, which is currently published six times per year. To keep the residents informed of the activities within the City Council, meeting minutes and agenda packets can be found at www.cityofdaytonmn.com. Announcements, events and many resources can also be found on the City's web page.

Ashton noted that Grace is a determined and confident advocate for herself and others, and she cares greatly about her coworkers and customers. "I really enjoy working with Grace, I admire her ambition and her determination and it's just been really enjoyable and fun to help her to set these goals and be able to take each step towards them," said Ashton.

Chamber Board of Directors Nominations Letter to Membership

TO: General Membership of the Anoka Area Chamber of Commerce

RE: Request for nominations for the Board of Directors of the Anoka Area Chamber of Commerce for three-year terms.

Article 6, Section 4 of the By-Laws of the Anoka Area Chamber of Commerce states that 135 days prior to the end of the fiscal year (September 30), all members in good standing shall be contacted requesting nominations for the Board of Directors, and is to be returned to the Chamber office no later than 120 days prior to the end of the fiscal year. At that time, the Board of Directors shall review the nominations and present a slate of five candidates to replace the directors whose regular three-year terms are expiring. The Board of Directors will confirm the fact by personal contact with the candidates, that they are willing to accept directorship responsibilities. Please keep in mind that any director nominated should be capable of serving as an officer of the Chamber, since officers are elected from the Board of Directors.




